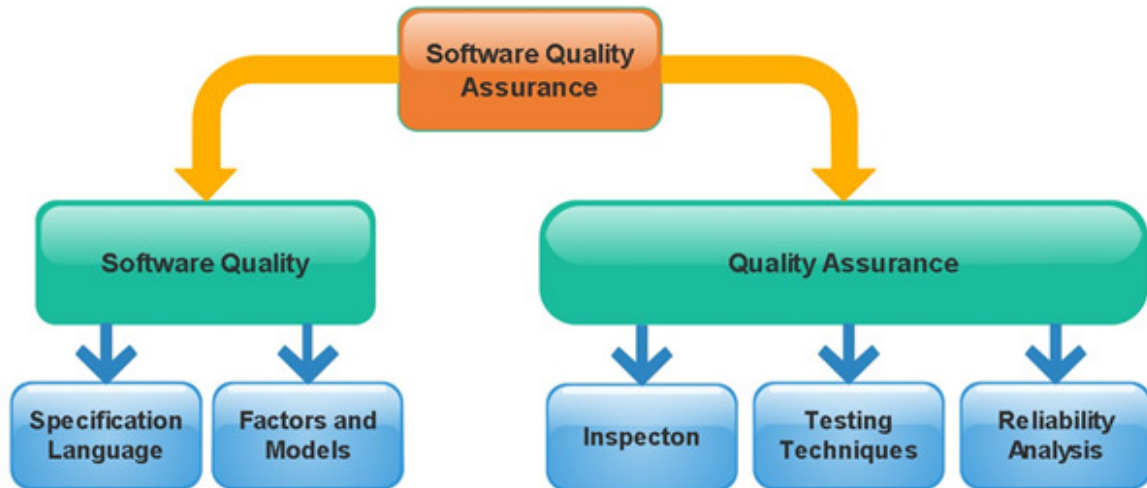


Fig1. Software Quality Assurance
